ADDITIONAL CAKE OPTIONS

Sheet Cakes

Only available in addition to a tiered cake, for weddings over 125 guests. Starting price \$3.00 per slice.

Cakesicle

A Cakesicle is basically a cake pop (cake crumbs combined with frosting, covered in chocolate) but in the shape of a popsicle. They come in a standard or mini size. \$54 or \$42 per dozen.

Cupcakes

Cupcakes are offered in quantities per dozen, with a starting price of \$36 per dozen.

ADDITIONAL FEES

DELIVERY: Minimum delivery fee of \$45. Increased fee depending on location and size of cake/order.

DESIGN ELEMENTS: Some examples of design elements that would add to the cost of a cake include intricate piping, metallic accents, fondant details, candy, cake toppers, fresh flowers (unless provided by florist/you), etc.

If you have a cake with multiple tiers, you may choose different flavors for each tier.

TASTING PROCESS

We offer a sample set of cake to try all flavor options. These sets are available once a month and will be delivered to you on that set date. Tasting dates can be found on miastavcakes.com, under the "Weddings" tab.

To order a set, fill out the Tasting Request Form (found on miastavcakes.com, under "Weddings" tab) at least one week before the set tasting date. You will then be sent an invoice for \$25, which must be paid to secure your tasting set. This money will go towards your deposit if you decide to book with us. A face to face consultation can be set up separately to chat design, pricing and details.

The tasting set will include a small sample of every cake, frosting, and filling flavor. Try out different combinations to find your perfect flavor! Then report back to schedule your design consultation.

PAYMENT

A deposit is required to secure your wedding date. Your order will not be guaranteed until that deposit is made.

The deposit amount will be **25%** of your total order price. This deposit is nonrefundable.

The remaining balance will be due 2 weeks prior to the wedding date.

The deposit and final payment will be made through an online invoice via credit/debit card.

Any late payments may be subject to late fees.

For cancellations within 2 weeks of the event, the entire amount of order is still owed.

FAQS

When should I order my wedding cake?

The sooner the better! Anytime between 12 and 6 months before the wedding.

Do you deliver? When should you deliver? And do you set up? How does that work?

Yes, we deliver all wedding orders and take care of whatever setup is required! We typically like to deliver a few hours before the wedding, once the linens are on, the table is set up, and the florals are available to place on the cake (if that applies to you.)

Who places the florals on the cake? You or the florist?

We prefer to place the flowers if possible!

Can you accommodate special dietary needs?

Unfortunately, no. We do offer a gluten friendly option, but it is baked with equipment that handles gluten products. We wouldn't recommend for an allergy, but for a sensitivity/intolerance that is up to your discretion.

CONTRACT

This Wedding Cake Contract is entered into by Mia Stav Cakes LLC and *Client Name* (the "Client"). Mia Stav Cakes agrees to deliver cake(s) as agreed upon and on time. The client agrees to pay Mia Stav Cakes for the production and delivery of cake(s). The following terms and conditions apply:

- A 25% deposit is required to secure the event date and is non-refundable. The remaining balance is due 2 weeks prior to delivery date.
- Payments made after due date are subject to late fees.
- Payments will be paid via credit/debit card through online invoice unless otherwise agreed upon.
- For cancellations within 2 weeks of the event, the entire amount of contract is still owed to Mia Stav Cakes.
- Any changes to the order are subject to availability, and must be made in writing no later than one month prior to delivery and may incur additional charges.
- Client assumes full liability and responsibility for the condition of the cake once it leaves Mia Stav Cakes possession.
- Client is responsible for providing an appropriate and secure environment for cake(s), i.e. a sturdy table and optimum room temperature of 75 degrees or below.
- The size of the tiers will be adjusted to accommodate the correct number of servings based on an industry standard slice of 8 cubic inches, 4 inches high, 1 inch wide and 2 inches deep. Mia Stav Cakes is not responsible for shortage of cake due to incorrect guest counts or failure to cut industry standard sized slices.
- Mia Stav Cakes reserves the right to use any photographs of the finished cake for promotion without compensation.
- Mia Stav Cakes promises a product of high quality and service, but is not liable for unforeseen circumstances, including but not limited to inclement weather, transportation problems, accidents, and other causes beyond reasonable control.
